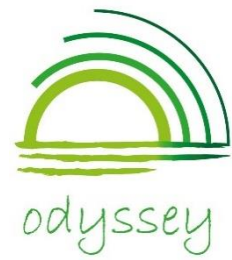

# fee schedule 2024

## one-off services

Establish Registered Pension Scheme	£750
Provision of documentation for the establishment of a registered pension scheme, together with assistance in relation to the various registrations required.	
Full Scheme Review	£600
An analysis of all scheme information provided to determine areas of compliance and areas of weakness. Recommended actions will be noted in a full summary report.	
Pension Scheme Return	£200
Compilation of information required for the completion of a Pension Scheme Return, including assistance in providing the information to HM Revenue & Customs.	
Pension Regulator Return	£150
Compilation of information required for the completion of a Pension Regulator Return, including assistance in providing the information to The Pensions Regulator.	
Provision of Scheme Documentation	£450
Analysis of the current Scheme Documentation with a view to ensuring that the Rules of the Scheme are brought up to date in terms of present pension legislation.	
Share of Fund Calculations	£250
Calculation of the share of the pension scheme attributable to individual members following the movement of monies into and out of the scheme over a three-year period.	

## annual services

Full Practitioner Service	£850
Provides for full technical and administrative assistance each year, including the appointment to the Scheme as Scheme Practitioner.	
Scheme Monitoring Service	£350
Provides for annual contact and interaction to determine whether the Scheme remains in a compliant form, including review of information and recommendations as to further actions that may be necessary.	

## additional services

Ad Hoc Services	Fixed Fee based on £150 per hour
Support and assistance can be provided in relation to all administrative and trustee requirements of the Scheme, including investment transactions, commercial property, sponsoring employer loans and retirement. Fee will be quoted in advance of the service.
